### Group Organiser Agreement

Water activities by nature are unpredictable and therefore inherently involves an element of risk. By allowing participants in my care to participate in water activities, I, the group organiser have the consent of the participant's parent/guardian and agree to the above terms and conditions and acknowledge that:

- a) I am aware of the inherent element of risk involved in water activities and accept responsibility for exposing participants in my care to such inherent risks.
- b) I have satisfied myself that the participant in my care has the necessary ability and knowledge to understand instruction and take part in water activities and to deal with conditions that may arise.
- c) I will not allow participants in my care to participate in water activities whilst under the undue influence of alcohol, drugs or whilst otherwise unfit to participate.
- d) I am responsible for the property of participants in my care whether afloat or ashore.
- e) I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions, or by actions or omissions of a participant in my care and their responsible parent/guardian.
- f) Any provision of safety boats and other shoreside support, does not relieve me of assumed parental/guardianship responsibilities or participants in my care of their responsibilities.

- g) It is my responsibility to make known any relevant ability, medical, and dietary condition that may affect a participant in my care or those supporting my group during the activity, any medication that they may require is solely my responsibility to store and administer.
- g) I agree to share such relevant considerations and essential information at the time of booking, and verbally and in writing to the lead instructor on the day of the activity.
- h) I understand that we need to arrive at least 15 minutes prior to the stated start time to complete the necessary paperwork and a short welcome and site induction.
- i) I understand that the stated finish time is the time the site is vacated (changing areas empty) and not the time we come off the water, off the water time is typically 15-20 minutes prior to finish time.
